

Privacy Policy

Greater Copenhagen Development

This privacy policy contains information regarding Greater Copenhagen Development ApS's (cvr-nr 44449722) ("Greater Copenhagen") processing of personal data. The purpose of this privacy policy is to make you aware of how Greater Copenhagen processes your personal data, what it's used for, who may view them and under what conditions, and how you can safeguard your rights.

Greater Copenhagen's role

Personal data controller

Greater Copenhagen is the personal data controller for the processing of personal data that takes place within the company's operations.

Information about how Greater Copenhagen processes personal data

General information

Within the framework of Greater Copenhagen's operations, the company processes personal data for customers and prospective customers. Furthermore, personal data is also processed for employees, prospective employees, suppliers, etc. which, however, is not covered in this document.

Purpose and legal framework

Greater Copenhagen has the following purposes and legal grounds for processing personal data.

- It is necessary to be able to enter into an agreement or implement and enter into agreements with customers.
- Regulatory compliance regarding legal obligations and executions of contractual obligations towards customers.
- Handling of requests.
- To the extent that we process additional data, we will obtain your consent or ensure that the processing is permitted on another legal basis.

What data is collected?

Greater Copenhagen strives to process as little personal data about you as possible. This means that no more personal data is collected than what is necessary to be able to enter contracts, fulfil contracts, or fulfil legal obligations.

Your rights

As a registered user, you have certain rights in relation to Greater Copenhagen. You can request that Greater Copenhagen:

- release information about all personal data that Greater Copenhagen has stored about you,
- correct personal data that is incorrect and supplement it with such personal data that is missing and that is relevant for the purpose of the personal data processing,



- delete personal data relating to you if the data is no longer needed for the purposes for which it was collected or to fulfill a legal obligation,
- limit the processing of personal data concerning you to certain limited purposes,
- facilitate the transfer of personal data if you yourself have provided the data and the processing takes place with the support of consent or to fulfill an agreement with you (data portability), or
- provide you with a decision by a person instead of any form of automated decisionmaking, including profiling, if the decision may have legal consequences for you or similarly significantly affects you.

Usage of cookies

A cookie is a small text file that contains data that is downloaded and stored on the device you use to access Greater Copenhagen's website. The cookies Greater Copenhagen use, normally improve the services the company offers. Some of Greater Copenhagen's services need cookies to function properly, while others improve the services for the visitor. As a visitor to Greater Copenhagen's website, you can consent to the use and storage of cookies. You can withdraw your consent to cookies being used for the above purposes at any time. You do this by specifying in the browser settings that you do not want to allow cookies. If you choose not to allow cookies, you can still use Greater Copenhagen's website, but the use of certain features and parts of our website may be limited.

Changes to the privacy policy

Greater Copenhagen reserves the right to change and update this data protection policy. In the event of material changes to the data protection policy or if existing data is to be processed in a different way than stated in the data protection policy, Greater Copenhagen will inform about this.
